The position will be based in The Bahamas and will report to the Chief Executive Officer or designate.

CORE DUTIES:

The successful candidate will be required to:

- Lead and promote the development of appropriate post liberalization reforms
- Provide direction and leadership on matters of policy and regulation, policy development and implementation and stake holder management
- Act as an advisor to the Board on matters of policy and regulation
- Provide leadership to a professional management team across disciplines of Economics, Law,
 Regulatory Finance and Telecommunications Engineering
- Prepare strategies and annual plans in accordance with the Board's policies and is consistent with its statutory obligations
- Oversee coordination of URCA's yearly policy and regulatory initiatives across its core functional units
- Establish internal policies and practices that would ensure timely and effective transfer of appropriate responsibilities and expertise from consultants and other external advisors to the organization and its members, in fulfillment of URCA's ongoing commitment to institutional capacity building,
- Attract, excite and retain employees within URCA toward the attainment of strategic objectives
- Pursue other specific projects as directed by the CEO and or the Board of URCA.

- Must hold a university degree, preferably at the post graduate level in the area of law, economics, accounting or business management or a professional designation that is equivalent, to be able to meet the intellectual demands of the job; and or equivalent experience
- Must have worked in, consulted in or regulated in comparative sectors (such as telecommunications, broadcasting, electricity or water) for a minimum of 8 years at a senior management/specialist level
- Superior understanding of the URCA and Communications Acts, and The Bahamas Electronic Communications Sector Policy
- Experience in managing post liberalization and competition policy issues will be an asset
- Experience in dealing with transformation and change at an organizational level will be an asset
